On a motion duly made (Dlugos/McKinney Cherry), and carried, with Wheeler and O'Hearn abstaining, the 2017 ARC Applications (project numbers 1701, 1702, 1703) for human services were approved.

On a motion duly made (Bartholomew/Olthof) and carried, the applications for Economic Development (project numbers 1704, 1705, df1706) were approved.

- 2. **NYSERDA Painted Post Update** STC staff continues to work with several municipalities to update their comprehensive plans to meet the NYSERDA Cleaner Greener requirements. The surveys for the Village of Painted Post and Village of Riverside have been distributed, and the survey returns are coming in. The analysis will be done in the next few months. The two villages will also be updating their zoning laws.
- 3. **2017** Conference Update The conference will be on April 6, 2017 at Corning Community College. Planning for classes has begun. Chelsea Robertson is discussing possible classes and presenters with NYSAC. If anyone has any ideas or suggestions for class topics, please contact Chelsea.

4. **Steuben County Transportation Study** – Gabriel Holbrow, STC Planner, reported that this study will focus on transit as a means to access services for the elderly and disabled and to enable employment for everyone. The focus is also on transit to meet the needs of people in the gap between Medicaid transportation and car ownership. A specific topic of interest is cross-county medical transportation.

The goal is to improve mobility without significant new services or costs and to increase utilization of existing formal transportation services, coordinate better among these services, and strengthen informal resources to cover gaps.

The project is funded by the Appalachian Development Public Transportation Assistance Program (ADTAP) and will run from August 2016 to December 2017.

5. **Flood Program Update** – Janet Thigpen reported the following:

<u>Levee Issues</u> – In response to discussions at DEC levee mapping training, STC is developing educational resources to increase awareness of the levees, the possibility of flooding in protected areas, and strategies for reducing those risks. Maps showing levees and protected areas will be distributed for posting in municipal buildings or other public places, along with a poster summarizing recommendations. A handout, Guidelines for Levee-Protected Areas, has also been developed for use and distribution by code enforcement officers (distributed at meeting).

<u>Flood Insurance</u> – People in areas protected by levees are advised to carry flood insurance. For those not in the flood plain, the insurance is not too expensive. Communities are better positioned to recover after a disaster if the damages are covered by insurance. Janet is finding that insurance agents are reluctant to sell policies in areas with no mandatory flood insurance requirement and no claim history. She would like to organize training for insurance agents about flood insurance and local flood risks.

6. **Other** – Ted Bennett reported that the I-86 Economic Benefits Study that was done in 2000 will not be updated at this time. The money that several agencies contributed will be returned.
